What is the CORC+ data set specification?

The CORC+ data set specification defines the content and format of the data set *submitted* to CORC annually by services following the CORC+ approach.¹ It does not intend to specify all of the data that services should *collect* locally. However, it does serve as a guide to the data we think are useful to collect for routinely monitoring service user outcomes.

What data files must be included in a data submission for CORC+?

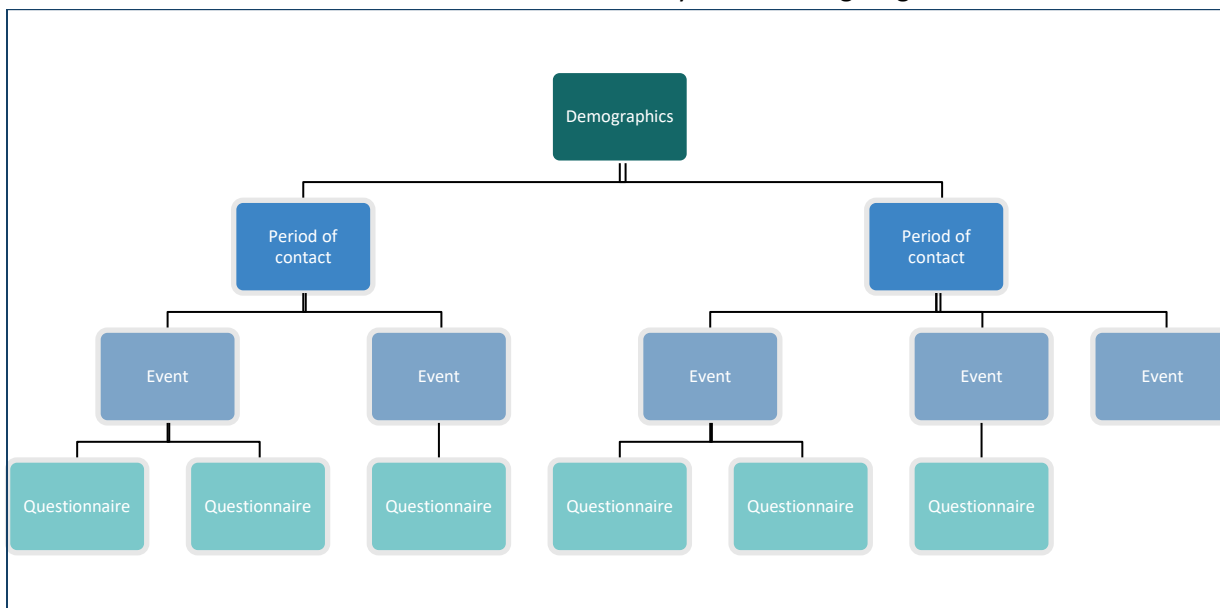
Three data files must be included in the data set for every submission:

- DEM (service user demographic data)
- POC (data on service users' periods of contact)
- EVENT (data on events within periods of contact e.g. sessions, questionnaire completions)

At least one questionnaire data file should be included in a data submission. The reason this document has so many pages is because of the number of different questionnaires. You can ignore the pages for the questionnaire data files you are not submitting!

What are the relationships between the data files?

CORC+ data have a hierarchical structure as illustrated by the following diagram:



The means that the following relationships apply:

- Each questionnaire record submitted in a QUES file type must also be submitted with an entry in an associated Event (EVENT) file, period of contact file (POC), and Demographic (DEM) file.

¹ A data set is a collection of observations or measurements about the children and young people seen by your service. In the case of the CORC+ data set specification, the data are arranged into multiple tables of data, saved as Comma Separated Values (CSV) files.

- Each Event record submitted in an EVENT file type must be submitted with an entry in an associated period of contact file (POC), and Demographic (DEM) file.
- Each Period of Contact record submitted in a POC file type must be submitted with an entry in an associated Demographic (DEM) file.
- Each Demographic (DEM) record submitted will not have an associated parent as it is at the top of the file hierarchy.

Please ensure files do not contain any personally identifiable information

Files prepared according to this data set specification should not contain any personally identifiable information. The CORC+ dataset is a deidentified dataset which means direct identifier fields such as name, date of birth, address and NHS number are not included in the specification. Please ensure submitted files do not contain these fields.

Please check the SERVICE_ALLOCATED_PATIENT_ID field and remove any personally identifiable information. We ask that SERVICE_ALLOCATED_PATIENT_IDs do not contain or are not derived from any direct identifiers e.g. name, DOB, NHS number.

Required file format: Comma separated values (CSV)

Comma delimited files are the required file format for delivery.

CSV files should have the following attributes:

- CSV Files should use a windows-style line termination (CR+LF)
- CSV Files should quote strings also containing commas, e.g.,
 "this, is an acceptable string"
 this, is not
- CSV Files should use a date format of "yyyy-mm-dd".
- CSV Files should have a header row containing field names (see definitions).
- CSV Files should be encoded as UTF-8.

CSV file definitions

This section sets out the fields that must be included in each CSV file. **All fields specified must be included in the CSV files being submitted, even if they don't contain any data.** Those fields marked 'mandatory to submit' must contain data in every row.

Demographic file (MUST BE SUBMITTED)

The Demographic file contains the service user-level data records. This file has no “Parent” file. There must only be one Demographic File submitted per Data Submission File Set.

Filename convention

[service_ID] is the service identifier of the originating service. If you are unsure what your service identifier is, please get in touch with the CORC team.

[yyyymmdd] is the date the file was created in the form year, month, date. E.g. 20120131 (31st January 2012)

Mandatory fields are indicated with a “Y”. If data in any mandatory fields is missing, then the entire file will be rejected.

Data submitted in Fields marked Updatable “N” will **not** be updated following subsequent submissions of changed data. In other words, the first submitted value will be retained for these fields.

This file must be submitted with a corresponding Period of Contact file containing a related Period of Contact record. There should only be one Event File submitted per Data Submission File Set.

[yyyymmdd] is the date the file was created in the form year, month, date. E.g. 20110131 (31st January 2011)

Mandatory fields are indicated with a “Y”. If data in any mandatory fields is missing, then the entire file will be rejected.
